WHEN TRADING SPOT FOREX, YOU BUY AND SELL THE CURRENCY PAIR AT THE CURRENT MARKET RATE, KNOWN AS THE SPOT PRICE. FOREX TRADING IS A WAY TO SPECULATE ON INTERNATIONAL CURRENCIES WITHOUT TAKING OWNERSHIP.

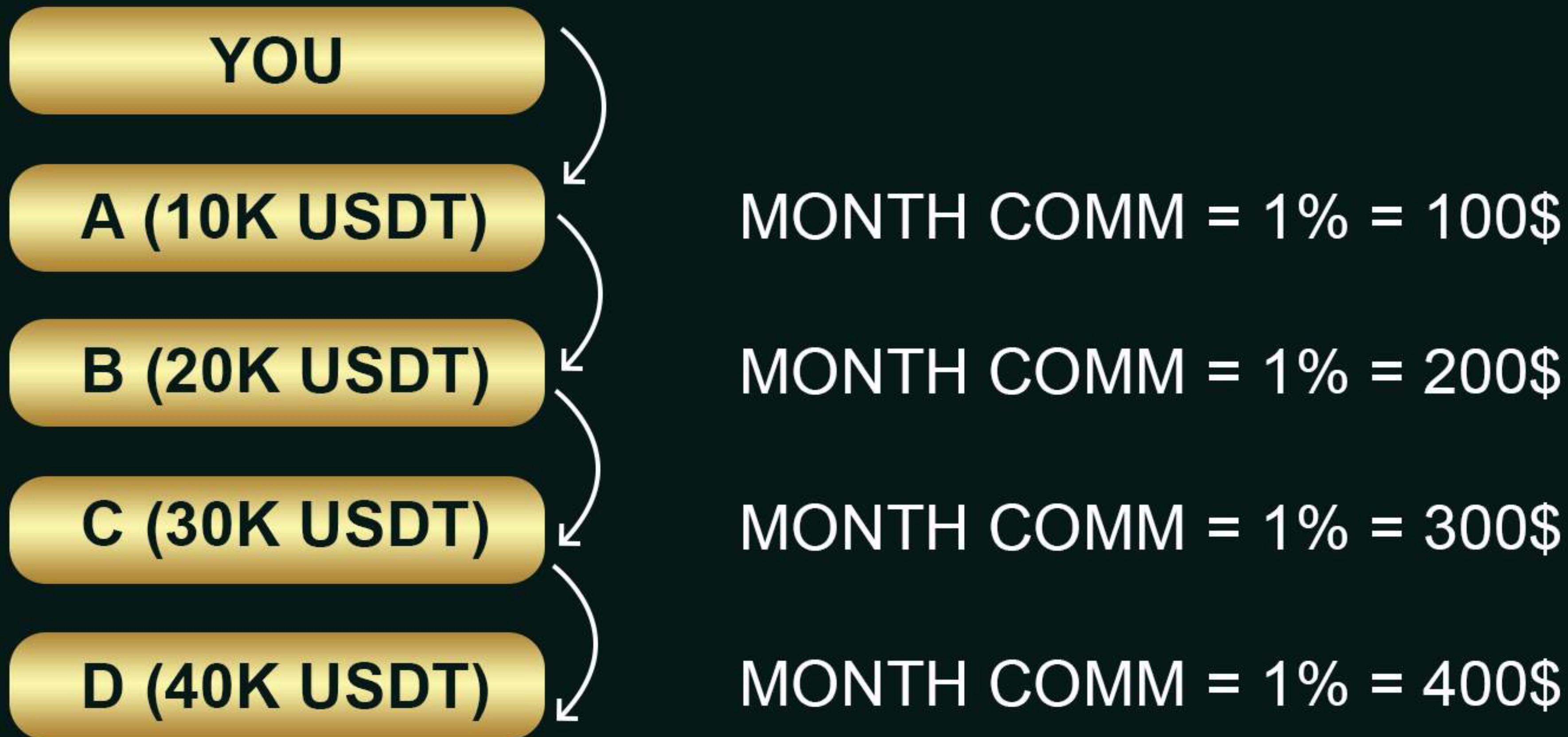

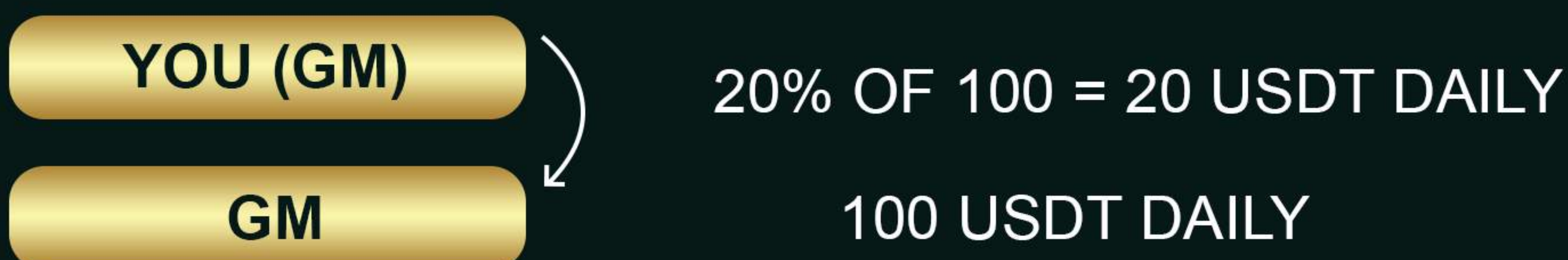
